## FINAL JUDGMENT ORDER

By orders dated March 19, 2021 and July 22, 2021, the Court granted summary judgment in favor of Defendants Competitive Enterprise Institute and National Review, Inc., as to all of Plaintiff Michael E. Mann's claims against the same. This matter came before the Court for a jury trial on Plaintiff Michael E. Mann's remaining claims against Defendants Rand Simberg and Mark Steyn that began with jury selection on January 16, 2024. On January 18, 2024, the Court empaneled a jury, whereupon all Parties presented opening arguments and Plaintiff commenced his case-in-chief. On January 31, 2024, Plaintiff rested his case-in-chief. On February 7, 2024, Defendants rested their cases-in-chief. That same day, the case was submitted to the jury after all Parties presented closing arguments. On February 8, 2024, the jury returned a special verdict in favor of Plaintiff against both Defendants.

ACCORDINGLY, it is this 9<sup>th</sup> day of February 2024, hereby

**ORDERED** that, pursuant to Rule 58(b)(2)(A) of the Superior Court Rules of Civil Procedure, **JUDGMENT IS ENTERED** in favor of Plaintiff Michael E. Mann and against Defendant Rand Simberg in the amount of \$1.00 of compensatory damages and \$1,000.00 in punitive damages; and it is further **ORDERED** that, pursuant to Rule 58(b)(2)(A) of the Superior Court Rules of Civil Procedure, **JUDGMENT IS ENTERED** in favor of Plaintiff Michael E. Mann and against Defendant Mark Steyn in the amount of \$1.00 of compensatory damages and \$1,000,000.00 in punitive damages; and it is further

**ORDERED** that, pursuant to Rules 54(b) and 58(a) of the Superior Court Rules of Civil Procedure, **JUDGMENT IS ENTERED** in favor of Defendant Competitive Enterprise Institute and against Plaintiff Michael E. Mann in the amount of \$0.00; and it is further

**ORDERED** that, pursuant to Rules 54(b) and 58(a) of the Superior Court Rules of Civil

Procedure, **JUDGMENT IS ENTERED** in favor of Defendant National Review, Inc. and against Plaintiff Michael E. Mann in the amount of \$0.00; and it is further

**ORDERED** that this case is **CLOSED**.
